in Doña Ana County and the surrounding Southwest Region formerly known as the Doña Ana County Immunization Coalition.

An open invitation was extended to attend the initial SwNMIC forum so feedback could be gathered as to what support can be offered to local providers that are involved in immunization programs, such as the Vaccines for Children (VFC) Program, Boo to the Flu, and other

immunization outreach clinics such as Hepatitis, HPV, Meningitis, and SKIIP.

The free app provides access to recommended immunization schedules and footnotes, and the most current version of the following vital information:

- Adult schedule, including recommended vaccines for adults by age group and by medical conditions
- Adult contraindications and precautions table
- Child and adolescent schedule with vaccine

• Catch-up schedule for patients 4 months through 18 years

Features of the App

- Colors match printed schedules
- Hyperlinked vaccine name opens as a pop-up with dose specifics
- Related resources and websites
- Any changes in the schedules will be released through app updates
